It is further understood and agreed that the foregoing shall be and will constitute the limit of liability for any injuries (including death) that I may incur, providing claim is filed within thirty (30) days of accident.

In consideration of the acceptance by WSS of my license application and issuance of license, and the foregoing, I do hereby release, remiss and forever discharge WSS, the promoters presenting races, and/or other events under WSS sanction, the owners and lessees of premises in which WSS sanctioned races or other events are presented, and the officers, directors, agents, employees and servants of all of them from liability claims, actions and possible causes of action whatsoever that may accrue to me or my heirs, next of kin, and personal representatives, from every and any loss, damage or injury (including death) that may be sustained by my person and property while in, about and enroute into and out of premises where WSS sanctioned race or other events are presented.

The undersigned consents to the use of his name and/or pictures of himself and his car, for publicity, advertising, and endorsements, both before and after events, relinquishes any rights to photos taken in connection with events, and consents to the publication and/or sale of such photos by WSS.

With respect to all individuals and/or corporations or businesses (and the employees thereof), involved in any legal proceeding which includes WSS, Management reserves the right to:
