I HEREBY CERTIFY THAT UPON THE ISSUANCE OF A 2023 WALL STADIUM SPEEDWAY PIT LICENSE,

1. I have read and understand the 2023 General Rules.

2. I will conduct myself in a reasonable manner while on the property. I will treat all patrons in the pit area and employees of Wall Stadium Speedway with respect at all times.

I will not intentionally cause harm to any person. I will not intentionally damage any personal property, including theft. I will never assault or attempt to assault an official.

I understand that the consequence is removal from the property either temporarily or permanently.

3. I will not threaten fellow competitors or their family/crew members, verbally or on social media. I understand that making threats has serious consequences.

4. I will not bash and trash the race track on social media. I understand that posting negative comments on the internet about the race track and its staff and management will cause damage to it. I agree to support Wall Stadium Speedway as long as I compete in race events here.

5. I agree that photographs taken of me and my race team by Wall Stadium Speedway photographers or other approved media personnel may be used by Wall Stadium Speedway for advertising and marketing purposes.

6. I will not use the Wall Stadium Speedway logo for unauthorized purposes. I will seek permission before using the track's logo on any shirts, signage, etc.

7. I will be entitled only to the benefits provided by the Benefit Plan of Wall Stadium Speedway for injuries (including death) that I may incur in any race meets. It is further understood and agreed that the foregoing shall be and will constitute the limit of liability for any injuries (including death) that I may incur, providing claim is filed within fourteen (14) days of accident.

In consideration of the acceptance by Wall Stadium Speedway of my license application and issuance of license, I do hereby release, remiss and forever discharge CK Motorsports LLC dba Wall Stadium Speedway, the promoters presenting race events, and/or other events at the venue, the owners and lessees of premises in which Wall Stadium Speedway sanctioned races or other events are presented, and the officers, directors, agents, employees and servants of all of them from liability claims, actions and possible causes of action whatsoever that my accrue to me or my heirs, next of kin, and personal representatives, from every and any loss, damage or injury (including death) that may be sustained by my person and property while in, about and enroute into and out of premises where Wall Stadium Speedway sanctioned race or other events are presented.
